In order to avoid and remove future breakdowns in our supply chain due to bad or poor quality bar code and label scans **Colony Brands Non-Food** has selected **StreamLine Labels (Asia & USA)** as its "authorized & preferred" label provider for package labels. (*Single Unit Labels, Master Carton Labels, COO, Toy Lot Code Package Labels & Suffocation Warning Labels*).

StreamLine Labels has created an online ordering process for our vendors at www.StreamLineLabels.com and **guarantees** that all labels printed meet our compliance guidelines or they pay the fines and penalties associated with EACH label. (NOTE: this does not include typographical errors on your order form or label placement on the product.) With offices and production facilities in the USA, Hong Kong, China, Vietnam and India they print and forward the labels to your factories and or Distribution Center for application to the unit and master carton. (See *the Vendor Compliance Manual for chargeback information.*)

When registering with StreamLine Labels choose "Colony Brands Non-Food" as the trading partner and include your primary Vendor ID Number.

Barcode Specifications

Barcode Required	YES
Barcode Format	Code 128 (A, B or C)
Minimum Barcode Height	1" (25.4 mm, 96 pixels, 1000 mils, 2540 HiMetric)
Minimum Barcode Length	1 1/2" (38.1 mm, 144 pixels, 1500 mils, 3810 HiMetric)
Barcode Grade	ANSI Grade "A" or "B"
Quiet Zone / White Space	A minimum 1/8" white space must remain on the left and right of the barcode.
Embedded Barcode Data	Package Label Number (PLN #) (The embedded barcode data is your 6 or 7 digit PLN# only . . There are no letters or text, only numbers. No leading or ending zeros, check digits or other special characters. NOTE: This is NOT a upc code or upc number.) Example: PLN# 650245 should read 650245 when scanned.

Unit Label Placement

Label Placement	Largest FLAT surface (Labels are placed on the package of the single unit, not on the item. The single unit package may be a plastic bag, corrugated carton, plastic carton, retail carton, clamshell, etc.)

Do not place the single unit label next to or over your UPC barcode.

Avoid placing any other barcoded labels on the same side as single unit label.

Items that are too small for a 2" x 2" single unit label must be placed in a polybag and apply the label to the polybag. Polybags MUST be sealed.

Do not place the single unit label over packaging seams.

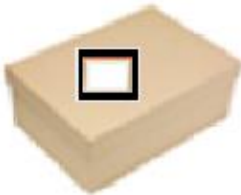

Master Carton Label Requirements

Master cartons contain 2 or more single units. If your package is single unit master/remailer please follow "Single Unit Labels" instructions on page 3.

Minimum Barcode Length	2 1/2" (63 mm, 240 pixels, 2500 mils)
Barcode Grade	ANSI Grade "A" or "B" or "C"
Quiet Zone / White Space	A minimum 1/8" white space must remain on the left and right of the barcode.
Embedded Barcode Data	Package Label Number (PLN #)

(The embedded barcode data is your 6 or 7 digit **PLN# only**.)

There are no letters or text, only numbers. No leading or ending zeros, check digits or other special characters. NOTE: This is NOT a upc code or upc number.) **Example:** PLN# 650245 should read 650245 when scanned.

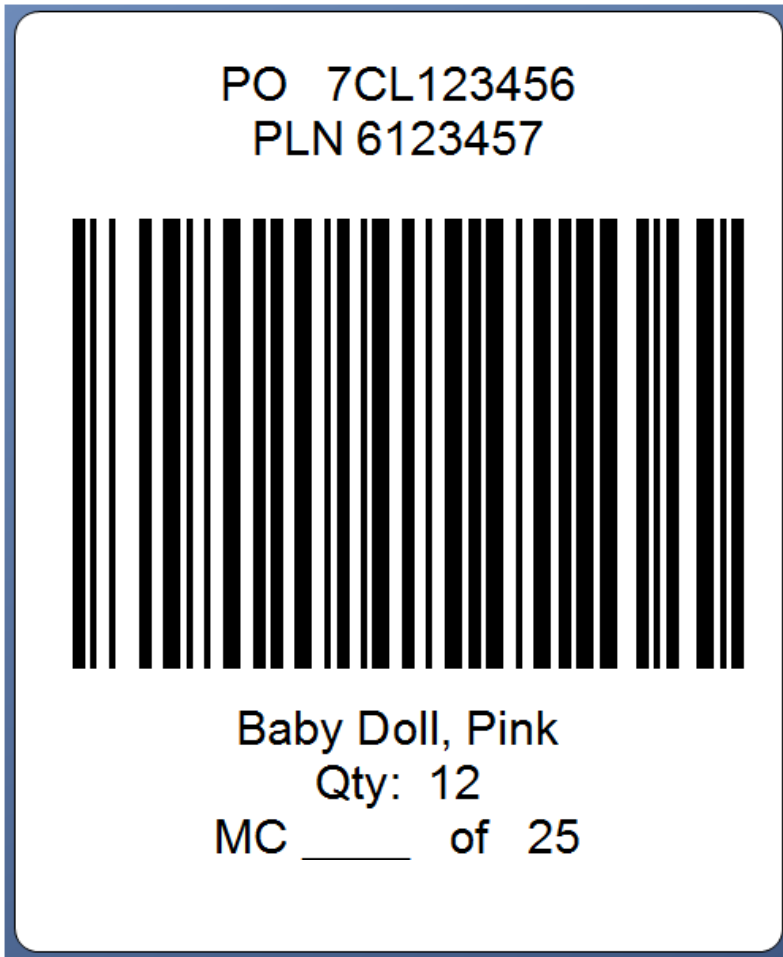

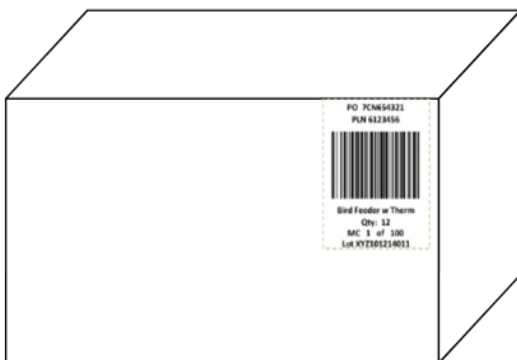
Note: Master carton label information may be printed directly on the master carton. When printing directly on the carton you will need to produce a 2 1/2" x 2" barcode (following barcode specifications above) on white label stock and place it in the upper right corner of the master carton. If you print required master carton text markings directly onto the master carton, please submit image of carton markings with barcode for approval.

Label Approval Process

All labels printed by StreamLine Labels do not require pre-approval. For a fee StreamLine Labels will review and validate your labels for you. They can provide you with service in a timely manner in the US, Hong Kong, China, Vietnam and India. Please see page 2 for contact information.

For approval from the Colony Brands Non-Food Packaging Department you will need to start the process a **minimum of 10 business days** prior to your expected ship date. ***Please note that the approval process only needs to be done once. Please do not send labels for every PO.***

- 1) Create a final template for each label
 - 1 master carton label sample
 - 1 single unit label sample
- 2) Print your samples on the media (label stock) you will be using
 - If printing required text (PO, PLN, Qty, MC__) on master carton, please provide images of markings
- 3) Fill out the Label Review Request Form (found on page 8)
- 4) Apply label samples to page 9 of Package Label Specification Document
- 5) E-Mail printed label samples and request form to: NonFoodPkgLabels@ColonyBrands.com
- 6) The Packaging Department will reply to you via email with approval or needed corrections

Label template approval is required on first shipments for each factory or you may receive chargebacks.

Label approvals will be provided once per factory only. They are not done per PLN or per PO.
Repeat submissions will be refused.

Note that approval of your template does not alleviate your responsibility to provide quality printed usable labels on the product packaging or the resultant chargebacks:

- Due to poor print quality of labels applied to actual product packaging
- If product packaging labels are not applied in the correct location on the packaging
- If a different template other than the approved template is used to produce your labels and resultant scan issues occur
- If incorrect information is used when creating each unit label

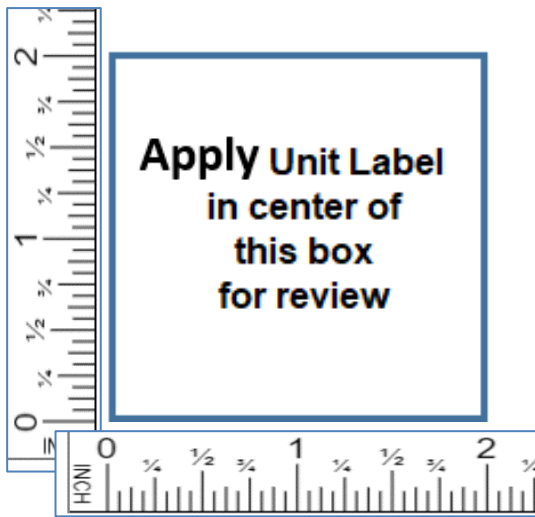

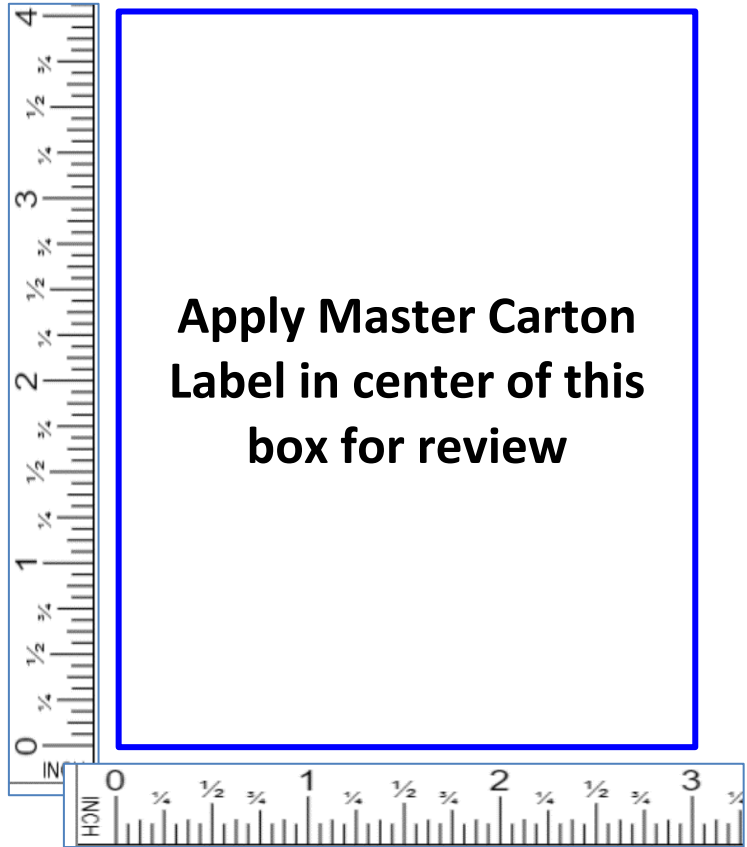
